

# Income Eligibility Guidelines for Free and Reduced-price Meals or Free Milk

**Effective from July 1, 2019 to June 30, 2020**

Households with income at or below the following levels may be eligible for free and reduced-price meals or free milk. The household size and Income Eligibility Guidelines charts below have been prepared for you to copy and paste them into the Media Release and Letter to Households. Please note that the size of these charts will need to be adjusted manually.

## **National School Lunch and School Breakfast Programs**

- Both free and reduced-price eligibility scales must appear in the Public Media Release
- Only the reduced-price eligibility scale must appear in the Letter to Households

## **Special Milk Program**

- Only the free eligibility scale must appear in the Public Media Release and Letter to Households
