## **Inviting All Licensed Contractors to Register on the Plaza Elementary School District Bidders List**

Notice is hereby given that the Plaza Elementary School District (the “District”) has elected to participate in the California Uniform Public Construction Cost Accounting Act (CUPCCAA).

Public projects, as defined by the Act and in accordance with the limits listed in Section 22032 of the Public Contract Code will be allowed to contract by informal procedures as set forth in Sections 22032-22045 of the Public Contract Code. All licensed contractors are invited to submit the name of their firm to the District for inclusion in the District’s list of qualified bidders for calendar year 2019.

Interested Contractors are required to complete and submit to the District the “Plaza Elementary School District Bidders List Information Form” which can be found on the District webpage at [www.plazaschool.org](http://www.plazaschool.org). The form is under the School Info tab and titled California Uniform Public Construction Cost Accounting Act (CUPCCAA).

Contractors are to download this form, provide all required and requested information, and submit the form to the Superintendent, 7322 County Road 24, Orland, CA 95963. Completed forms may be submitted via email to [pconklin@glenncoe.org](mailto:pconklin@glenncoe.org) for receipt on behalf of the District, or via facsimile to: (530) 865-1252. All submittals, via email or facsimile, must be clearly labeled “Plaza Elementary School District CUPCCAA Bidders List Information Form Submittal”. Information required on the form will include, but not be limited to:

1. The name and complete address, including zip code.
2. The telephone and facsimile numbers and e-mail address.
3. The Class of the Contractor’s License(s) held and Contractor License Number(s).
4. The type(s) of work in which the Contractor is interested and currently licensed to perform, such as, but not limited to, General Engineering, General Building, or Specialty Contracting such as, Electrical, Mechanical, Plumbing, Structural, Heating, Ventilating, and Air-Conditioning (HVAC), Earthwork, Pipelines, Painting, Carpentry, Concrete, Demolition, Excavation, Landscaping, Masonry, Painting, Roofing, Etc.

This announcement is sent to various trades journals for publication as a requirement of the CUPCCAA procedures to establish and maintain a list of qualified contractors per the applicable sections of the Public Contract Code. This invitation shall also be subject to any and all applicable laws, regulations, and standards.
