Resolution 19-05

**RESOLUTION AUTHORIZING TO TAKE ANY AND ALL
NECESSARY ACTIONS TO PREPARE AND RESPOND
EFFECTIVELY TO THE NOVEL CORONAVIRUS (COVID-19)**

WHEREAS, on March 4, 2020, the Governor of California declared a State of Emergency due to the outbreak and spread of a novel coronavirus (COVID-19); and,

WHEREAS, on March 11, 2020, the World Health Organization officially declared COVID-19 a global pandemic; and,

WHEREAS, on March 13, 2020, the President of the United States declared a national emergency due to COVID-19; and,

WHEREAS, as of March 13, 2020, there are 237 cases of COVID-19 reported in California, and officials expect the number of cases to increase; and,

WHEREAS, strict compliance with various statutes and regulations would prevent, hinder or delay appropriate actions to prevent and mitigate the effects of COVID-19; and,

WHEREAS, it is imperative to prepare for and implement measures to respond to the potential spread of COVID-19; and,

WHEREAS, it is imperative to have the tools to ensure the health of safety of students, staff, and families on our campuses; and,

WHEREAS, it is imperative to have the tools to ensure student learning continues if student education needs to be conducted from alternate locations or virtual learning environments; and,

WHEREAS, it is imperative that employees be allowed to take a leave of absence due to being quarantined or recently returning from level 3 countries or sick from COVID-19, or cohabitating with any individual with COVID-19; and,

NOW, THEREFORE, BE IT RESOLVED, that the Plaza Elementary School Board of Trustees:

(1) Determines that the circumstances described in the Resolution herein constitute an emergency condition; and

(2) Authorizes the Superintendent and/or his designee to take any and all actions necessary to ensure the continuation of public education, and the health and safety of the students and staff at the District sites, including, but not limited to: provision of alternative educational program options and provision of leave of absence to employees due to being quarantined or recently returning from level 3 countries or sick from COVID-19, or cohabiting with any individual with COVID-19.
