About This School

Plaza Elementary School District is a small single school district situated on almost 10 acres in the Sacramento Valley 100 miles North of Sacramento and 7 miles East of Orland California in Glenn County. Plaza School is the oldest school in Glenn County and was established around 1865. Plaza is a K-8 district that serves 142 students. The kindergarten, first and second grade are single grade level with combination classes in third-fourth, fifth-sixth and seventh-eighth. The primary industry is agriculture, agribusiness and business.

School Facilities

Summary of Most Recent Site Inspection

No significant deficiencies were noted during the 2008 facilities inspection in any of the eight areas stressed in the Williams v. State of California suit. The areas inspected include: gas leaks, heating, ventilation, fire extinguishers, electrical power, septic system, pest control, doors, windows, gates, hazardous materials, and structural damage.

Repairs Needed

No repairs were needed with the exception of a stair way leading to the parking lot. The stairway and two adjacent entranceways were not at the proper grades per the American with Disabilities Act. Some areas are in need of modernization within the main building.

Corrective Actions Taken or Planned

The above listed discrepancies are currently in the process of being corrected. Modernization funds will be pursued in 2010-2011 school years.

School Description and Mission Statement (School Year 2008-09)

Plaza School District is a small, rural, K-8 direct service school located in Glenn County, outside the city limits of Orland. The community is supported mainly by agriculture. Plaza is a single school district. Six full time teachers and a full time superintendent staff the school. Plaza also has a part time music teacher.

School enrollment averages 140 students. Class size averages 17 to 1 in single each with one teacher. Plaza then transitions into combination classes with a 3/4th, 5th/6th, and 7th/8th classroom with class averages approximately 30 to 1. Kindergarten has a two hour aide and grades 1 & 2 have a one hour aide. Half-day aides work in the 3/4th, 5th/6th, and 7th/8th classrooms.

To promote a lifelong love of learning through a positive and supportive school climate that provides the opportunity for all students to achieve their full educational and social potential. School staff, students, parents and community members will provide support that encourages high expectations for all students.

Parents at Plaza School play very important roles through their active participation and involvement in School Site Council, Community Club, and various annual events. Parents volunteer their services in and out of the classroom. Parents serve on the school site council as well as the community club. The SSC is involved in oversight of certain federal revenues as well as providing input for the school safety and technology plans.

The community club is involved in community fund raisers such as the pancake breakfast and spaghetti feed. They utilize the proceeds of these fundraisers to fund projects such as the planters on the West side of the parking lot and the new playground equipment installed four years ago. Parent involvement is a key component for the continued success of Plaza Elementary.

School Facility Conditions and Planned Improvements (School Year 2009-10)

The permanent building which houses three classrooms, a cafeteria and kitchen was built in 1974. In addition there are five portable classrooms and a trailer used by the County Office of Education for special education classes. A major building project was completed in 2004 that consisted of four classrooms, administrative offices, staff room, and restrooms. When finished the older portables will be demolished or put to other uses such as storage, band room, etc. When the district's building project is finished the Glenn County Office of Education will begin construction of a special education facility to house the severely handicapped program now housed in a portable. Also improvements to the playground and ball fields were conducted in 2006. An excellent custodial staff maintains all buildings and grounds.

Currently in the process of acquiring state approval of classroom complex built in 2005. Earthquake modifications and ADA requirements now being addressed for spring 2010 approval. The main building built in 1974, is in need of some minor to moderate repairs and upgrades. Plaza is inquiring into the eligibility of Modernization funds to be used in conjunction with existing bond funds to perform those upgrades. A bus shed and classroom upgrades are also being considered moving forward.

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics, and science in grades two through eleven, and for science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades three through eight and science in grade five and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities and English language learners is reported based on three levels (identified, excluded, and assessed). Detailed information regarding the NAEP results for each grade, performance level, and participation rate can be found on the [National Assessment of Educational Progress](#) Web page (Outside Source).

Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
