Plaza Teachers' Association consulted July 17th, August 10th, and August 28th, 2020. Classified staff are not part of a labor organization but were consulted via a whole staff survey.

X Parent and Community Organizations

August 21st, 2020- A survey was sent out via a Google Form to all Plaza School families. Of the respondents, 92% selected Yes when asked if they supported Plaza School District applying for the waiver.

Plaza Community Club (PCC) and School Site Council (SSC) consulted August 25th, 2020-Superintendent Conklin held a video conference with PCC officers and members of SSC. PCC is Plaza School's parent teacher group, while SSC is an advisory group of teachers, parents, and the administrator who meet three times a year to review and discuss state plans in order to make recommendations to the board of trustees. In the meeting, the Superintendent discussed the waiver process and Plaza School's plan for reopening.

In this video conference, 100% of the participants approved applying for the waiver, including three Plaza School teachers.

If no labor organization represents staff at the school, please describe the process for consultation with school staff:

On August 25th a survey was sent to all staff members, including certificated and classified staff, as well as Glenn County Office of Education staff members who work with Plaza School's Special Education students.

Of the respondents, 90% selected Yes when asked if they supported Plaza School District applying for the waiver.

Elementary School Reopening Plans

Cleaning and Disinfection

Cleaning and disinfecting the school will occur throughout the day using state and local public health guidance and procedures. Staff will train using Golden State Risk Management Authority's Target Solutions safety training program. The purpose will be for staff to utilize approved practices when cleaning and disinfecting campus.

Areas such as counters, sinks, doorknobs, railings, restrooms, etc. will be cleaned and disinfected throughout the day, as well as before students come in the next day.

Additional hand sanitizing stations were installed in every classroom, outside bathrooms, and the office/cafeteria entrance. Air purifiers were installed in every classroom and the school office.

Sharing any school materials and supplies among students and staff will be limited. Students will be provided with their own set of materials and supplies.

Cohorting

Plaza School is a one school K-8 district with only 146 students in K-6. The goal is a slow, gradual reopening where we will begin with 25% of each K-6 class on campus per day for several weeks. If cases remain low in Glenn County, and there are no widespread outbreaks at Plaza School, we will have 50% of each class on campus per day.

Although the cafeteria capacity is 264 people, there will be no more than 40 students eating in the cafeteria at one time. When weather permits, students will eat outside. All tables and benches will be disinfected after use.

Recess time will be staggered between K-2 and 3-6th grades. Furthermore, areas will be designated per class to prevent cross contamination.

There are only 9 children who ride the school bus. Siblings will sit in the same row with students sitting in every other row. Seating will begin in the last row and work towards the front. Masks will be worn and windows will be open.

There will not be field trips or assemblies. The sports and music programs are suspended until further notice. No classroom volunteers or visitors are permitted on campus.

Entrance, Egress, and Movement Within the School

There is only one building with a hallway. It has three entrances/exits, two of which are used for students. When the bells ring, students will line up six feet apart and the teacher will be waiting for them. Classes will enter/exit one group at a time.

All classrooms will remain closed before school starts. All parent/student/teacher meetings must be prearranged.

Facial Coverings and Other Essential Protective Gear

Facial coverings are mandatory for all adults and 3rd-8th grade students on campus. Facial coverings are recommended for K-2 students. PPE gear will be provided to anyone who does not have a facial covering. Face shields are available for staff and plastic barriers will separate adults from students. Touchless thermometers have been purchased.

Students who do not want in person instruction due to concerns over exposure, or facial coverings and social distancing will continue with distance learning.

Health Screenings for Students and Staff

Staff already received training on how to identify COVID-19 symptoms from the Glenn County Office of Education School Nurse prior to school starting.

Parents and staff will be asked to screen at home prior to coming to school. Any student or staff member showing symptoms that include: 100.3 or higher temperature, chills, coughs, shortness of breath, difficulty breathing, fatigue, muscle or body aches, headache, sore throat, congestion, runny nose, loss of smell or taste, and/or diarrhea must stay home. Prior to entering campus, all students will be screened for all of the aforementioned symptoms, except for temperature check. If any student or staff member exhibits symptoms while at school, the they will be separated, a temperature check will take place, and will be sent home with a recommendation to get a COVID-19 test.

Healthy Hygiene Practice

One reason to start in person instruction in cohorts of 25% of the class is to better educate small groups of students on respiratory etiquette, proper hand-washing, and social distancing. Students will be reminded at the beginning of each day of in person instruction. Parents will receive regular reminders via email, text messaging, and phone calls.

Hand sanitizer stations are outside the cafeteria, office, and every classroom. Students and staff will wash hands using soap and water or hand sanitizer prior to entering and exiting the classroom, office, or cafeteria.

Identification and Tracing of Contacts

The superintendent/principal and school nurse will support local contact tracing. The school nurse is also responsible for contact tracing with Glenn County Public Health Department, will document and track potential exposure, and notify public health when necessary.

Physical Distancing

With no more than 50% K-6 capacity (approximately 75 students), students will easily maintain social distancing while in classrooms. Desks will be arranged in such a way that students will not face each other. All adults are required to maintain 6 feet from all others. Physical barriers will separate adults from students.

Signs are posted stating that facial coverings and social distancing is required.

Staff Training and Family Education

Custodial staff will participate in appropriate cleaning and disinfecting training through Golden State Risk Management Authority Target Solutions.

Triggers for Switching to Distance Learning

Due to Plaza School's small class size, when one positive case in a cohort has been identified, the cohort will be closed for 14 days from exposure and consultation with local public health recommendation. If there are positive cases in multiple cohorts or at least 5% of the total number of people, school will be closed for 14 days since exposure and consultation with local public health.

Communication Plans

Although the school community will be notified when there is COVID-19 exposure, student and staff privacy must be maintained. When a positive case is confirmed by Glenn County Public Health Department, community notification will be made via an all call and text message. All "Close Contact" (individuals who have been within 6 feet for 15 or more minutes) will be notified by a personal phone call to ensure direct communication. Close Contact individuals will be required to distance learn for 14 days since exposure and will be recommended to receive testing.

Plaza School will work with Glenn County Public Health to provide as much information as possible so they can conduct contract tracing.
